

## INVESTOR LOANS – PRO DOC STANDARD

<b>PRO DOC STANDARD 70 - 9.54%</b>	
<b>Purpose</b>	Owner-occupied or investment property purchases, land only, construction and re-financing existing residential loans.
<b>Income Verification</b>	Investment – No income declaration required just affordability declaration Owner Occupied – Affordability and Income declaration required
<b>Loan size</b>	From \$30,000 to \$1,000,000 per security property
<b>Term</b>	Up to 30 years
<b>Repayments</b>	Principal and interest or interest-only for 2, 3, 5 or 10 years. Line of credit: 15 years.
<b>Frequency</b>	Weekly, fortnightly or monthly. Extra repayments can be made on variable loans at any time.
<b>Convert to fixed rate</b>	All or part of the loan can be converted to a fixed rate at any time at a cost of \$250.
<b>Split loan facility</b>	Up to four separate splits per facility each with separate loan statements. Transfer funds between splits using Inter-Account Payment facility.
<b>Line of Credit Facility</b>	Add 0.20% to the interest rate (has debit Mastercard and a cheque book)
<b>Re-draw facility</b>	Unlimited re-draw at no cost. Minimum re-draw \$50 when using Loan Service Line or Loan Service Net for all variable-rate loans.
<b>Pay anyone</b>	Payment can be made to any bank, building society or credit union directly from your loan using a valid BSB and account number (excludes credit cards). Maximum of \$5,000 per day. Not available during a fixed-rate period.
<b>Maximum LVR</b>	70% for all loans.
<b>Application Fee</b>	\$440
<b>Valuation Fee</b>	\$250 (depends on quoted value of property)
<b>Settlement Fee</b>	\$0
<b>Lenders Solicitor Fees</b>	\$385 (plus disbursements)
<b>Lenders Mortgage Insurance</b>	\$0 (Is required for all loans. The premium is payable by the funder up to \$750,000 loan size).
<b>Ongoing Fees</b>	\$0

- All repayments to be made by electronic direct debit or direct credit;
- No minimum net asset position required;
- No minimum self-employment period;
- Security to be located in mainland capital cities;
- Registered first mortgage over residential property required as security on all loans.
